I understand that I am entering into a binding agreement between myself and the trustee for Forgiven Souls Dog Rescue for adoption of a rescue animal. I confirm that I have read this entire agreement carefully and fully understand all aspects before signing.

1. I understand that I am adopting a dog under the age of 4-6 months old and therefore has not yet been spayed or neutered (desexed). I understand that the adoption fee includes this operation and it is MANDATORY that it be performed. I agree that I will make an appointment with a veterinarian approved by Forgiven Souls Dog Rescue to have this dog altered when the dog turns 4-6 months of age (depending on sex). Forgiven Souls Dog Rescue will pay for the operation if I use a veterinarian approved by them, and I will be responsible for the expense if I use another veterinarian to perform this operation. This dog must also be provided with an e-collar once procedure is complete.
2. Female dogs are to be desexed at 6 months of age. Male dogs are to be desexed at 4 months of age.
3. Once the dog has been desexed, I will provide Forgiven Souls Dog Rescue with a copy of the dogs spay/neuter certificate, and a photograph of the tattoo on the dogs ear.
4. I understand that the microchip details assigned to the dog shall remain in Forgiven Souls Dog Rescue name until points one and two of this agreement have been completed in full.





5. If this dog has a medical condition around the time of desex that is going to delay the operation, a letter from an accredited vet is to be provided to Forgotten Souls Dog Rescue, at my expense, detailing the reason for this delay.
6. I agree to register the dog with my local council and maintain current dog registration on reaching 6 months old as per the "Companion Animals Act 1998 NSW" or applicable legislation. I will provide a copy of this registration to Forgotten Souls Dog Rescue on receipt; I agree that I shall maintain this registration throughout the life of the dog.
7. I agree that the dog is being adopted as a companion pet and will not be used as a working, guard or hunting dog.
8. I agree that the dog will be provided with proper food, water, shelter, exercise and necessary veterinary treatment. That the dog will be given a loving home and not be kept solely in the yard without interaction.
9. I agree that any cross breed references are an assumption and have been advised, and that this may not be accurate and may change as the dog grows.
10. This dog has been examined by Forgotten Souls Dog Rescue veterinarian prior to his/her adoption and has received all vaccinations appropriate to the age of the dog. Forgotten Souls Dog Rescue will provide copies of these records on completion of the adoption.
11. I agree to maintain the dog (at my own cost) up to date with all vaccinations, wormers & flea treatment.
12. If the animal is currently under veterinary care, I confirm that I have been notified of any current medical conditions as far as Forgotten Souls Dog Rescue are aware of and have been provided with one course of medication that the dog is currently taking. I understand that any veterinary problems that may now arise with this dog, including serious illnesses requiring emergency care or surgery are now my responsibility, and I will bear all related costs and will provide the proper veterinary care to the animal in a timely manner.
13. I agree that Forgotten Souls Dog Rescue or their assigned representative may make a visit at a mutually convenient time to ascertain that all of the above conditions are being satisfied. If Forgotten Souls Dog Rescue contacts me to enquire regarding the dog, I agree to make a good faith effort to return Forgotten Souls Dog Rescue) message as soon as possible.
14. If I change my address or telephone number I will notify Forgotten Souls Dog Rescue within three (3) weeks of my new address or phone number.
15. I understand that in the event I can no longer keep the dog due to injury, illness, accident or any other reason and are unable to fully care for the dog, I will notify Forgotten Souls Dog Rescue and will work with them to place the dog in an approved home. I confirm that I understand that this dog may not be sold or given away under any circumstances.
16. I understand that the adoption fee is GST free and is non-refundable.
17. I understand that Forgotten Souls Dog Rescue may reclaim the dog, if in their opinion, any of the above conditions are not met, or the dog is being mistreated or abused. I understand that I will be liable for any fees or costs incurred by Forgotten Souls Dog Rescue out of the enforcement of this agreement. I agree that in the event the dog is demanded back due to non-compliance with this agreement, I forfeit all rights to the dog and no compensation shall be provided.
18. I understand that if I have not met the requirements for spay/neuter by the time the dog is 6 months of age, then ownership shall immediately revert to Forgotten Souls Dog Rescue upon demand as per point 15 of this agreement.



As the adopter, I agree to accept full and lasting responsibility for the care of this dog. I agree to abide by the adoption conditions and realise that I am committed to this dog for his/her life. I have read and fully understand the conditions laid out in this agreement.
